### Minutes

Susan distributed the October minutes to all in attendance. A correction will be made to the minutes to show board approval of the Statement of Financial Position only. The Statement of Activities/Previous Year Comparison was not approved, as there were a few line items that need further review/adjustments made with accounting. After the above changes have been made, Kristi made a motion to approve, Bonnie seconded and all approved the October minutes.

# **Treasurer Reports**

Karen reported the Sunday, November 29<sup>th</sup> ice time will be cancelled. Ice on Monday, 11/30 from 5:15 to 6:15 will be dropped. Ice from 6:15 to 7:15 will be dedicated to Holiday Show finale practice.

### 2015 Holiday Show

SFFSC will be performing a Holiday Ice Show on Sunday, December 20<sup>th</sup>, from 5:00 – 6:30pm. Deadline for sign up is 11/18. Sarah Hanson will be directing this year's show. Skaters are limited to one number, (\$35 fee) in addition to participation in the finale. Participation is open to SFFSC Competitive Team/FS skaters.

We will need volunteer assistance with bake sale, decorations, MC, music players and ticket sales (Adults \$5, Kids \$3)

## **Ice Classic**

The 2<sup>nd</sup> Annual Sioux Falls Ice Classic will be held March 12<sup>th</sup>/13<sup>th</sup> 2016. Bonnie will be chairing the planning committee. All are welcome to attend the kick-off meeting on Thursday, November 12<sup>th</sup> from 6:00 – 7:00pm. Decisions in regards to vendor options and hotel arrangements will need to be made very soon.

#### **Policies**

The policy committee presented a "draft" of SFFSC "Ice Rules" to the board for approval. After review, Kristi made a motion to adopt the new ice rule policy effective January 1<sup>st</sup>, 2016, Michelle seconded and all approved. Michelle made a motion to leave participation prices the same as last year--\$95 for 1<sup>st</sup> group number, \$60 for second group number, \$30 for small groups (duets/trios/quartets) and Seniors are "invited" and will not be charged for their senior solo. Kristi seconded the motion, and all approved.

SFFSC will be offering another sale after the first of the year. New Club Jacket information will be available soon.

# **On-Ice Jump Harness**

Discussion took place regarding future purchase of an on-ice jump harness. An accrual account had been set up and money is being set aside annually for this future purchase. Michelle will gather detailed information from Patty G., who had done some research on our options at the time the rink was built. The contractors for the IcePlex did account for this item to be housed in the Stampede rink and had access to the "specs" for its future installation. A decision must be made whether to wait until funds set aside for this item reach the amount needed, or if additional funds, through extra fund raising, grants or sponsorships can be used for its purchase soon. This decision will be tabled until the March 2016 meeting.

Michelle made a motion to adjourn the meeting at 10:10, Susan 2<sup>nd</sup>, all approved.
